Our team of passionate attorneys provide free legal representation and advocacy to survivors across all 5 boroughs boroughs of NYC.

Dedicated to providing holistic and comprehensive legal advocacy and representation for survivors, our lawyers provide a variety of legal assistance. Advocacy efforts range from robust consultations at legal clinics to full representation and litigation when needed.

Attorneys travel across boroughs providing workshops and clinics within the communities where victims live, making it easier for survivors to access services. Our legal team's proven track record of success is largely attributable to their close relationships with their clients. We are continually inspired by our clients every day in the work that we do.

NEW CLIENTS

Over 1,216 new victims were seen this year and screened for needs.

Because our clients often have multiple legal needs, we opened 1,700 new cases.

FAMILY LAW

Family law is the backbone of what we do- so often victims' most pressing issue is securing the safety of them and their children.

We were able to provide 228 clients with assistance on their custody disputes, 172 with help obtaining orders of protection, 235 with divorce and over 110 help with child/spousal support.

IMMIGRATION

The newest and fastest growing service area, our immigration unit has opened over 400 new immigration cases, which include U-Visas, T-Visas, VAWA, naturalization cases, removal defense, asylum and SIJS matters.

ADVOCACY SERVICES

The critical element to DVP's success has been our team of devoted advocates and social workers.

Often working hand in hand with our legal team, our advocates accompany clients through every step of their journey. The range of services they assist with are vast and constantly adapting to meeting the changing needs of our client base. While legal assistance is often necessary, more often the non-legal intervention is what drives the client's success and ability to truly move on from the abuse.

This includes our Financial Empowerment Program. Recognizing the connection between financial stability and domestic violence, DVP provides financial literacy and empowerment services to provide survivors with the tools that will help them to remain out of abusive relationships.

Our advocates and social workers provide:

- Intake assistance
- Safety planning
- Advocacy
- Immediate and longer term crisis counseling
- Support groups focused on empowerment and stress reduction
- Case management assistance
- Housing assistance and shelter placement
- LINC/FHEPS aftercare
- Public benefits application assistance
- Financial empowerment services
- Court accompaniment
- · Referrals and technical assistance

NEW ADVOCACY CASES

DVP opened over 440 new case management matters this year and 22 intensive long term counseling matters.

Advocacy cases range from benefits assistance to financial and housing assistance and more

FINANCIAL & HOUSING

167 clients assisted cure rent arrests, obtain safety transfers, LINC recertification and referrals for housing court.

OUTREACH & EVENTS

Monthly clinics and outreaches are conducted throughout NYC's communities. On average, we hold 10 events per month specifically tailored toward financial abuse, amounting to 120 a year. Additionally, DVP hold social events for clients to increase their support network of peers.

SUCCESS STORIES

While numbers may help demonstrate our success, a client story better illustrates our work and the impact that your donations have driven...

Taylor, an immigrant victim of severe emotional, financial and sexual abuse at the hands of their spouse first came to us through the family law team who successfully negotiated an uncontested divorce for the client and also secured an order of protection. As a result of the DV, Taylor applied for a "U-Visa" and eventually received work authorization.

From this success came many more as Taylor began home health aide courses through our partnership with a local HHA agency, eventually becoming officially certified by the Department of Health.

Our Financial Advocate and Family Law attorney also assisted the client in applying for Innocent Spouse Relief with the IRS in the hopes of alleviating the financial burden of the tax debt incurred by Taylor's spouse without client's knowledge.

About a year after our initial application, Taylor was granted full relief- in the amount of over \$2,000. Taylor was able to use this money toward securing an apartment.

As you see, your support directly assisted this client reach so many life changing milestones-legal status, protection from abuse, divorce, employment certification, housing stability.


PROGRAM UPDATES
